## General Issues

- Citations, references, and tables are to be formatted based on the APA style ( $7^{\text {th }}$ edition).
- The manuscript is to be thoroughly checked for its language. Some required revisions are as follows:
- Page 1 , line 30: "considerably contributes to master" $\rightarrow$ "considerably contributes to mastering."
- Page 1, line 30: "for communicative competence" $\rightarrow$ "for communicative purposes."
- Page 1 , line 35: "since the daily communication uses a native language" $\rightarrow$ "since daily communication in an EFL context is conducted in a language other than English."
- Page 1, line 36: "mastering listening materials" $\rightarrow$ "mastering listening skills."
- Page 1, line 37: "limitation of listening strategy use, and a shortage of vocabulary": these last two instances are rephrased so that they point out to difficulties learners might encounter.

Abstract<br>- Page 1 , line 8: "are rarely well confirmed" $\rightarrow$ "has rarely been well confirmed".<br>- Page 1, line 11: in fact, two tests have been employed.<br>- Page 1, line 16: "inferential statistics with t -test" $\boldsymbol{\rightarrow}$ "inferential statistics ( t test)."<br>- Page 1, line 23: "in successful listening instruction" $\rightarrow$ "in listening instruction."<br>- There is no need for keywords to be italicized.
